Owen, does not leave doubt at all about this being an attempt to strike a severe blow to freedom of thought and to set a legal precedent to start right afterwards a country-wide general campaign of repression against all the radical press in particular, but in general against all those newspapers that in one way or another might hurt or get in danger the interests which safety is based on a diminution of human freedom and on a restriction of the welfare and justice that all men and women of honest aspirations have a right to enjoy.
