
After many years of suffering under the yoke of reactionary "bosses" in the various divisions and departments that govern the safe operation of the Panama Canal, that sector of employees designated as "Silver Employees" has finally decided to organize in a solid block and launch out toward the betterment of the workers in general. This fight is a long and hard one and will need the cooperation of every employee as well as that of all other progressive sectors in the Canal Zone as well as in the Republic of Panama.

We cannot deny the fact although several attempts to orga nize labor were made in the past, they failed miserably. We must learn from the mistakes made in the past and avoid these pitfalls, outstanding of which was the inability of the various nationalities to cooperate. We are, all of us, Panamanians, West Indians, Salvadorians etc., suffering the same bad conditions and injustices on the same jobs-be it as laborers, food-handlers, clerks and so on all the way down the line. Hence the necessity for organizing all, work ers regardless of race, color, creed, or national origin for the common good.

The fact that this Union was able to inscribe 3000 members in the first six weeks of its existence and 7000 more in the next three, serves as proof of the necessity of such a Union. They have realized tha this fight is not for one individual but for the working masses joined in one solid block. This is but the beginning of whats to come.

METAL TRADES COUNSEL DECLARES WAR ON UNITED PUBLIC WORKER OF AMERICA

In the June 7th, 1946 issue of "Government Standard" official news paper of the A.F. of L. no less than 14 columns of vile slander has been hurled at the newly formed. United Public Workers of America.

Although the A. F. of L. has had no part in the recent fight for the 181/2 cents hourly raise, they accept with no gratitude this increase in their weekly pay checks. Instead they hurl epithets in honey covered poison coated attacks. We all know the C. I. O. is a fighting Union without discrimination as to race, color, creed or national origin (see constitution). We also know the A. F. of L. is a decadent, dying organization filled with hate, prejudice and highly discriminatory tactics. To prove this they ally themselves with the most reactionary groups in America—such as the Hearst Press and Scripps - Howard Chain, both of which are anti Negro. anti labor monopolies In the issue of June 7th, the "Govt. Standard" reprints no less than 3 editorials from this vicious group and 14 columns of red baiting. One of the writ. ers for Hearst, Walter Win-

chell, was sued for slander and lying attacks againts the C.I.O. and had to pay ten thousand dollars to the C. I. O. in a decision handed down by the Supreme Court of United States. The "Govt. Standard" never mentioned that. The "Govt. Standard' never mentioned a recent incident in Atlantic City either. In pure jealousy, the A. F. of L. decided to "organize the South" The C. I. O. has been engaged in this murderous task for many years and now that the battle is begining to bear fruit. the A. F. of L. suddently finds itsef concerned with the Southern Negro and is also beginning to or_ ganize the South. A conven. tion was called in Atlantic City but when twenty five Negro delegates entered the auditorium, the ushers herded them all into a corner of the auditorium in typical Jim Crow fashion. No, the "Govt. Standard" says nothing about this but confuses their membership with red-baiting the United Public Workers of America. In this they directly follow the reactionary lines of Hearst and Scripps Howard newspapers.

ARTICLEII.—OBJECTS

1) To bring about the effective organization of the working men and women of the Canal Zone regardless of RACE, CREED, COLOR, or NATIONAL ORIGIN, and to unite them for common action into a labor union for their mutual aid and

2) To extend the benefits of collective bargaining and to secure for the workers means to establish peaceful relations with their employers (The United States Government) by forming a labor union capable of dealing with modern ag-gregates of the U.S. Government in the interest of the Work. ers of the Canal Zone.

3) To maintain determined adherence to obligations and responsibilities under collective bargaining and wage agree-

. 4) To secure legislation safeguarding the economic security and social welfare of the Workers of the Canal Zone, to protect and extend our democratic institutions and civil rights and liberties and thus to perpetuate and realize the cherished traditions of democracy.
