UNION CONDUCTS IMPORTANT **NEGOTIATION WITH ADMINISTRATION**

RE-EMPLOYMENT POLICY, EFFICIENCY RATING SYSTEM, AND INCREASED MEAL ALLOWANCE DISCUSSED

Extensive negotiations have been conducted by the Union with the Panama Canal Administration over the past three weeks.

The negotiations dealt with the rate of pay for personnel reemployed in the same division, and submitted recommendations for the improvement of the current efficiency rating system, as well as recommendations that would increase the meal allowance for "silver" employees.

Urges Favorable Change in Re-employment Policy

The delegation, consisting of International Representative Foster Bournes; Cecil Hall, Financial Secretary, and organizer Roland Dean in speaking on the re-employment of personnel in the same Division. recommended that such re-employment be made at the last in-grade step of the employee provided that the classification is the same and the re-employment occurs within a reasonable period of time from the date of separation.

The Union cited an example wherein an employee of a Panama Canal Division had been employed since April 1946 as Luggerman, Grade 3-C, 38¢ per hour and after having been given a reduction in force, efrective March 5th, he was subsequently re-employed as Luggerman, but at Grade 3-A. thereby suffering a 4¢ per hour cut in wages.

This, the Union pointed out, was an injustice, and contended that there was no justifiable reason for a wage cut.

Increase In Meal Allowance Sought

The meal allowance of \$1.20 per day established for employees transferred from their official stations was also the subject of considerable discussion.

The Union, in its argument, maintained that this allowance was not sufficient to cover the cost of adequate meals. As a result of this insufficiency the employees are forcer to augment their allowances with their own funds.

It was recommended that this allowance be increased to \$1.95, enough to cover the cost of three meals that are of the minimum caloric value.

As a justification for its request for increased meal allowances, the Union submitted data on illustrated sample meals taken from the menus of the Panama Canal Clubhouses that totaled \$1.95.

These sample meals represented the minimum amount and variety of food required for the diet of a worker.

Union Seeks Changes in Rating System

Three recommendations were submitted to the Administra-

tion for incorporation into the rating system to be ultimately adopted. The Union took the position that the acceptance of these proposals would reduce to a minimum the probability of error, misunderstanding and ar-

"Races of Mankind" Author Blasts "Silver"

Discrimination

Dr. Gene Weltfish, co-author of the famous pamphlet, "The Races of Mankind," and professor of Anthropology of Columbia University, attacked dis crimination against Panama Canal "silver" employees at the Cultural and Scientific Conferonce for World Peace held recently in New York City.

Dr. Weltfish described in vivid terms the economic and social discrimination practiced against the "silver" employees and compared wage scales between "silver" and "gold" Workers performing the same jobs.

The professor cited the role of the A.F. of L. in the maintenance of sub-standard conditions for "silver" workers and read from testimony they gave before Congress in which Panamanians and "silver" employees were vilified and slandered. He cited the loyalty record of the employees and asked if the A.F. of L. could caual that record.

Richardson Testifies Against Measure

Thomas Richardson, UPW Anti-Discrimination Chairman, strongly urged the Senate Committee to omit the discrimiratory McCarran provision and adopt the same policy as the House Committee. He told the Appropriations Committee:

"I would like to stress the human factors involved in the continuation of the McCarran amendment insofar as Panama Canal appropriations are concerned. It would be an inhuman action to retain that amend ment which would bring about the firing of these old and faith fu! employees who are not citizens of either the United States or the Republic of Parama who braved malaria, yellow fever, and rock slides to help build the Panama Canal.

"If these workers had not been available for the rigorous duties during construction days, it would have been necessary for American workers to perform these jobs and be expesed to these dangers. So in actuality, the very workers who would be affected by the

TIME FOR A GENERAL WAGE INCREASE

Few cheers from the "silver" employees greated the announcement of the Administration that within-grade increases would be granted on June 26th of this year. From past experience only about 25% of the employees will receive these raises. For the most part they will consist of two or three cents per hour. A comparatively small number of the employees in grade eleven and above will receive four cents or more for their within-grade raise.

Thus the within-grade raises will not ease to any effective extent the pressing economic problems confronting the "silver" employees. Those employees in step E of their classification have no opportunity to obtain a within-grade increase. The most distressing situation is faced by the "frozen" workers.

The "frozen" employee did not receive any increase when the classification program was innaugurated during February, 1948, although hundreds of other workers received raises ranging from 2 to more than 10° per hour. When the general 4° per hour raise was granted in July, 1948 the "frozen" employee was again left out. The within-grade increases granted in January, 1949, brought not one cent to the "frozen" employees, and the "within-grade" increases announced for (Continued on page 3)
