EDITORIAL

THE LABOR CONFERENCE

Published elsewhere in this issue is an article in relation to a conference of the United Labor Syndicates of the Republic of Panama, slated for the 21st and 22nd instant. From information gleaned through both a reliable and unimpeachable source, deep interest is being taken in this conference, and we note with much elation, the topics which are of far reaching and great importance to labor in general to be discussed at this conference as was brought to our notice a few days ago. Sometime about two months ago, we stressed the imperativeness of all concerned toget together for the good of our ourselves -all for one and one for all- in unity there is strength, and we are indeed proud to see that so far fruit has been borne thereby. We congratulate immensely those gentlemen who saw it fit to come together, as a result of which, the subject conference is made possible.

Of course, this being the first attempt, we are sanguine that every desired wish cannot be obtained, however, we are looking forward with anxiety to the laying out of solid ground on which to place the foundation and the subsequent erection of a permanent structure to the cause of labor here on the Isthmus of Panama. This alone is sufficient cause to anticipate a successful conclusion of every subject handled. The ladies, God bless them. Also, the committee acted wisely in its requesting a representative of one from a group of any twenty-five persons of any particular trade or calling to take part in the conference. This augurs well; and the far-sightedness of the committee in this as well as other directions should be commended. In congratulating the several organizations (labor) for the step taken in bringing about the present conference, we wish for them every possible success; in high hopes that their deliberations will columinate satisfactory to all concerned; that none of the delegates will think of or fight for personal gain or ambitions, neither for their particular union or organization, but to the contrary, for the conference as a whole, bearing in mind the fact that UNITED WE STAND, DIVIDED WE FALL. Not we only, but the public in general will be watching the conference's every effort, therefore, our admonition: Be modest and discreet in the handling of every situation presented for action.

It has been brought to the attention of the Union, that certain employers in the City of Colon, despite the Executive Order of the President of the Republic of some two years ago, have resorted and are still resorting to the system of employing women in the capacities of cashiers, and Bar Tenders and Waiters in their establishments, thereby necessitating the discharge of males employees, members of the union. As this situation is contrary to the Government's labor policy, the Executive Officers of the Bar Tenders and Waiters Union, upon satisfactory proof, intend to approach the proper authorities, in the persons of the Honorable Governor the Honorable Alcalde of the Province, with a view of applying remedial and corrective measures to this open violation of authority.
